Starick Services can provide high quality accommodation for women and children affected by domestic violence. It has also proved to be an ideal venue for our monthly Board meetings.

The Board has focused on reviewing and consolidating the financial and governance aspects of the organisation. One of the priority areas has been the professional development of Board members. The Board participated in a strategic planning day with training provided by the Western Australian Council of Social Services Inc. (WACOSS) on the roles and responsibilities of Board members. The financial processes have been improved by contracting the financial operations to Nulsen Haven. The transfer of functions provided an opportunity for a comprehensive review of the finances of Starick Services.

Over the last year, the Board has recruited three new members: Kerry Regan, Lynette McGivern and Jenny Berry. They bring to the Board invaluable and diverse skills that complement the knowledge and experience of the current Board members. Unfortunately, we also bade farewell to two long term Board members with the departure of the former Chairperson John Gladstone and Deputy Chairperson Erica Lewin. Their contributions will be missed.

Starick Services is continuing its process of renewal and expansion. In 2010, we will be expanding our operations into regional areas, updating our policies and procedures, developing a website and reviewing our strategic plan.

I would like to take this opportunity to thank the Board for their incredible hard work and to staff for their strong commitment to maximising the safety and protection of women and children who access our services.



Reducing homelessness is a priority for both levels of government.

Since the introduction of the new Commonwealth/State
National Affordable Housing
Agreement (replacing
SAAP – Supported
Accommodation Assistance
Programme) last year, there
has been a significant
increase in much needed
new and expanded services.

The South East Metropolitan District (SEMD) was fortunate to gain fully funded outreach and housing support services which are complementary to the services that Starick Services currently provide. It is envisaged that these new and expanded services will work collaboratively with existing agencies to achieve greater levels of support, and substantially improve outcomes for those who are homeless, or at risk of homelessness.

The Western Australian Council on Homelessness was established in February this year and has been instrumental in developing a State Plan to reduce homelessness which is to be released by Minister McSweeney in the near future. The expansion of existing services and newly created initiatives will prioritise three areas; Early Intervention and Prevention; Breaking the Cycle; and Improving and Expanding the Services System.


I am aware that these three priority areas fit well with Starick Services three priority areas; Prevention; Intervention and Follow–Up, evidenced in the successful programmes currently being run. A special mention to all Domestic Violence Advocates in the Support, Prevention, Education, Advocacy, Referral Services (SPEARS) programme at each of the police stations; their expertise and experience provide a valuable and essential service not only to the police in the South East Metropolitan District but also the wider community.

Centre for Community

Since its inception in 1996 Support, Prevention, Education, Advocacy, Referral Services (SPEARS) has become a much valued resource, not only in the South East Metropolitan District (SEMD) but also state-wide. We have seen it grow from humble beginnings at the Armadale Police Station to now covering all seven police stations in the district including an outreach programme and a counselling service at Neerigen Brook Primary School.



In this past year the Domestic Violence Advocates have focused on working collaboratively with the South East Metropolitan District in the following ways:

- Provide and attend training-this is done in conjunction with the Domestic Violence Advocates and Police DV officers
- Home visits
- Dealing with increased demands for advice on domestic violence related matters
- Increased input on police procedures related to domestic violence

- Joint public relations activities (media releases in the local newspapers and The West Australian)
- Strengthen Starick Services/SEMD abilities in providing a more holistic approach to family and domestic violence
- Increased opportunity to follow-up on recidivist files (where there the police have attended six times at the same address), allowing greater information flow between all stations in the SEMD
- Comprehensive case management, although time consuming, has raised many issues which are currently being addressed through the partnership
- Cross fertilisation of skills and knowledge between both agencies
- Streamlining existing processes for referrals and follow up between both agencies
- Greater understanding of the impact of family and domestic violence on victims and perpetrators
- More awareness of police processes vital in understanding how victims can navigate the legal system

We are very fortunate to have dedicated and highly skilled advocates at each of the police stations.



Centre for Safety and Wellbeing



In the past twelve months staff have concentrated on developing new programmes and strengthening current projects to provide a wide variety of choices for clients accessing the Centres (Starick House and Mary Smith).

Experience has shown that these programmes are vital in strengthening women's self determination and offering many opportunities for 'up skilling' and broadening their knowledge base to increase their safety and overall health and wellbeing of themselves and their families.

Financial independence has been identified as of the utmost importance for women when leaving abusive relationships. This is promoted through staff working closely with families using the 'Budget Busters Booklets' designed by one of the Women's Support Advocates and presenting very successful weekly nutrition classes. The centres are fortunate to receive generous donations of fresh fruit and vegetables from the 'Birdman' which assist these classes and augment children's school lunches.

The 'Clothesline Project' is an international project to raise awareness of sexual abuse of women and children by hanging T-shirts with hand painted messages/slogans on a mobile clothesline in public. This is an ongoing project throughout the year, and produces fabulous work from the children and their mothers. At the last 'Reclaim the Night' March in October residents from Starick House, Mary Smith and Outreach clients displayed and sold their painted T-Shirts and aprons which was a highlight for both staff and families involved.

Centre for Non Violence


The Centre for Non Violence currently accommodates administration and the Op Shop in the City of Belmont.

As the central point of the organisation it provides resources and information and co-ordinates all public activities.

The Centre is in its infancy, and the following projects have been planned for implementation over the next three years;

- Training component with the ability to provide mobile services
- Development of specific family and domestic violence resources targeting indigenous and culturally and linguistically diverse communities
- Expanding the current Family and Domestic Violence Education and Support Groups
- Research and publications

It is envisaged that the Centre will provide professional and responsive services not only at a local level but also State and National.
